TOURNAMENT RULES

- I. **Eligibility:** Any female 18 years of age or older, member currently in good standing with USBC and Wisconsin Women's 500 Bowling Club is eligible (Dues are \$10 for LIFETIME membership).
- II. This tournament will consist of Doubles & Singles and optional All-Events.
 - A. Bowlers may enter **only once** in Singles Event, Doubles and All Events.
 - B. Entry fees must accompany the entry form. Bowlers wishing to bowl together must send entries in the same envelope. No fees will be refunded after start of tournament.
 - C. Reservations will be accepted for any number of entries. **Entries and fees are due within 14 days of the date of reservations.**
 - D. **Late Entries** (after the closing date) accepted until end of tournament (10/27) for an additional \$5 per bowler processing fee based on availability.
 - E. Handicap will be 100% of 235 scratch for singles & 470 scratch for doubles.
 - F. This tournament shall have (2) events:
 - Singles Division 1-170 & above, Division 2-145-169, & Division 3-144 & below.
 - Doubles Division 1-340 & above, Division 2-290-339 & Division 3-289 & below.
 - The Tournament Director reserves the right to alter or change the division average splits.
 - G. Substitutes and walk-ins will be permitted. The bowler must meet all eligibility requirements as above and be able to verify her average.
 - H. All events will be bowled on the same pair of lanes.
- III. **Entering average** (HIGHEST, in order by priority)—Entrant shall use:
 - A. Highest **2023-2024** season average **in a sanctioned USBC league** of at least 21 games.
 - B. Highest **2024-2025** season average (current season) **in a sanctioned USBC league** of at least 12 games minimum as of the participation date in the tournament (must present verification at check-in).
 - C. Bowl scratch in Division 1 with a scratch average of 235.
 - D. USBC Rule 319a will apply. The 15-pin increase provision of USBC Rule 319a (2) and reporting of prize winnings USBC Rule 319d.
 - E. **USBC YOUTH LEAGUE AVERAGE IS NOT ELIGIBLE.**
- IV. **It shall be each entrant's responsibility to verify the accuracy of her average. Failure to use the correct average shall disqualify scores if submitted average is incorrect. If you bowl in more than one association, it is the highest average of ALL associations.**
- V. All entrants must report 30 minutes before scheduled time of bowling for lane assignment.
- VI. All prize money will be returned 100%, on a ratio of at least 1 of 5 in each division depending on the number of entries in each division. All prize money will be disbursed within 30 days of the end of the tournament, **PENDING MEMBERSHIP VERIFICATIONS.**
- VII. Any player arriving late shall begin play and the score shall count beginning with the frame then being bowled.
- VIII. A bowler who misses one (1) or more frames by not being present and ready to bowl when it is her turn shall not be credited with any pins for the frames missed.
- IX. No food or beverage will be allowed in the settee area.
- X. Participants are requested to wear suitable attire while participating in the Wisconsin Women's 500 Bowling Club Tournament.
- XI. The tournament shall be under the management of the Wisconsin Women's 500 Bowling Club Board of Directors and the Secretary shall be the Tournament Manager. The board of directors shall have the power to hear and act on disputes, complaints, or protests relating to the tournament- The decision of the board is final.
